



## Who can use this form?

People with Medicare who want to join a Medicare Advantage Plan

### To join a plan, you must:

- Be a United States citizen or be lawfully present in the U.S.
- Live in the plan's service area

**Important:** To join a Medicare Advantage Plan, you must also have both:

- Medicare Part A (Hospital Insurance)
- Medicare Part B (Medical Insurance)

## When do I use this form?

You can join a plan:

- Between October 15–December 7 each year (for coverage starting January 1)
- Within 3 months of first getting Medicare
- In certain situations where you're allowed to join or switch plans

## What do I need to complete this form?

- Your Medicare Number (the number on your red, white, and blue Medicare card)
- Your permanent address and phone number

## Reminders:

- If you want to join a plan during fall open enrollment (October 15–December 7), the plan must get your completed form by December 7.
- Your plan will send you a bill for the plan's premium. You can choose to sign up to have your premium payments deducted from your bank account or your monthly Social Security (or Railroad Retirement Board) benefit.

### Paying Your Plan Premium:

If we determine that you owe a late enrollment penalty (or if you currently have a late enrollment penalty), we need to know how you would prefer to pay it. You can pay by mail, Electronic Funds Transfer (EFT), or Credit Card each month. You can also choose to pay your premium by automatic deduction from your Social Security or Railroad Retirement Board (RRB) benefit check each month.

If you are assessed a Part D-Income Related Monthly Adjustment Amount, you will be notified by the Social Security Administration. You will be responsible for paying this extra amount in addition to your plan premium. You will either

**have the amount withheld from your Social Security benefit check or be billed directly by Medicare or the RRB. DO NOT pay FHCP Medicare the Part D-IRMAA.**

People with limited incomes may qualify for Extra Help to pay for their prescription drug costs. If eligible, Medicare could pay for 75% or more of your drug costs including monthly prescription drug premiums, annual deductibles, and co-insurance. Additionally, those who qualify will not be subject to the coverage gap or a late enrollment penalty. Many people are eligible for these savings and don't even know it. You can also apply for Extra Help online at [www.socialsecurity.gov/prescriptionhelp](http://www.socialsecurity.gov/prescriptionhelp).

If you qualify for Extra Help with your Medicare prescription drug coverage costs, Medicare will pay all or part of your plan premium. If Medicare pays only a portion of this premium, we will bill you for the amount that Medicare doesn't cover.

If you don't select a payment option, you will get a bill each month.

If Social Security or RRB does not approve your request for automatic deduction, we will send you a paper bill for your monthly premiums.)

**If you currently have health coverage from an employer or union, joining FHCP Medicare Flagler Advantage could affect your employer or union health benefits. You could lose your employer or union health coverage if you join FHCP Medicare Flagler Advantage.** Read the communications your employer or union sends you. ### Attestation of Eligibility for an Enrollment Period

Typically, you may enroll in a Medicare Advantage plan only during the annual enrollment period from October 15 through December 7 of each year. There are exceptions that may allow you to enroll in a Medicare Advantage plan outside of this period.

Please read the following statements carefully and check the box if the statement applies to you. If we later determine that this information is incorrect, you may be disenrolled.

**By completing this enrollment application, I agree to the following:**

I understand that my response to this form is voluntary. However, failure to respond may affect enrollment in the plan.

FHCP Medicare Flagler Advantage is a Medicare Advantage plan and has a contract with the Federal government. I will need to keep my Medicare Parts A and B. I can be in only one Medicare Advantage plan at a time, and I understand that my enrollment in this plan will automatically end my enrollment in another Medicare health plan or prescription drug plan. It is my responsibility to inform you of any prescription drug coverage that I have or may get in the future. Enrollment in this plan is generally for the entire year. Once I enroll, I may leave this plan or make changes only at certain times of the year when an enrollment period is available (Example: October 15 - December 7 of every year), or under certain special circumstances.

FHCP Medicare Flagler Advantage serves a specific service area. If I move out of the area that FHCP Medicare Flagler Advantage serves, I need to notify the plan so I can disenroll and find a new plan in my new area. Once I am a member of FHCP Medicare Flagler Advantage, I have the right to appeal plan decisions about payment or services if I disagree. I will read the Evidence of Coverage document from FHCP Medicare Flagler Advantage when I get it to know which rules I must follow to get coverage with this Medicare Advantage Plan. I understand that people with Medicare aren't usually covered under Medicare while out of the country except for limited coverage near the U.S. border.

I understand that beginning on the date FHCP Medicare Flagler Advantage coverage begins, I must get all of my health care from FHCP Medicare Flagler Advantage, except for emergency or urgently needed services or out-of-area dialysis services. Services authorized by FHCP Medicare Flagler Advantage and other services contained in my FHCP Medicare Flagler Advantage Evidence of Coverage document (also known as a member contract or subscriber agreement) will be covered. Without authorization, **NEITHER MEDICARE NOR FHCP MEDICARE FLAGLER ADVANTAGE WILL PAY FOR THE SERVICES.**

I understand that if I am getting assistance from a sales agent, broker, or other individual employed by or contracted with FHCP Medicare Flagler Advantage, he/she may be paid based on my enrollment in FHCP Medicare Flagler Advantage.

**Release of Information:** By joining this Medicare health plan, I acknowledge that FHCP Medicare Flagler Advantage will release my information to Medicare and other plans as is necessary for treatment, payment and health care operations. I also acknowledge that FHCP Medicare Flagler Advantage will release my information, including my prescription drug event data, to Medicare, who may release it for research and other purposes which follow all applicable Federal statutes and regulations.
