### **Non-Medicare covered Preventive and Comprehensive Dental Services include:**

\$500 combined allowance for non-Medicare covered preventive dental services and non-Medicare covered comprehensive dental services every year.

Member is responsible for any amount over and above the allowance amount.

\*Amounts you pay for these additional non-Medicare-covered preventive dental services and non-Medicare covered comprehensive dental services do not count toward your in-network out-of-pocket maximum amount.

Exclusions: Dental services not listed above are not covered. This includes, but is not limited to, cosmetic dentistry (teeth whitening, orthodontia, etc.).
